The Administrator called the legislative session to order at **8:22** p.m.

Council Member Opel Jones, Council Member Deb Jung, Council Member Christiana Mercer Rigby, Council Member Liz Walsh, and Council Member David Yungmann were present.

ELECTION OF COUNCIL OFFICERS
