Dear Council Chair Walsh:

Section 13.1407 of the Howard County Code requires the Department of Housing and Community Development (the "Department") to provide an annual report to the Council on activities related to the Right of First Purchase legislation for the prior calendar year.

For the year ending December 31, 2024, a list of the rental communities that provided notice of an offer to sell or a contract of sale is attached. The County did not exercise the option to purchase any of these communities and no rental units were acquired by the County under this legislation. The Howard County Housing Commission exercised the Right of First Purchase to acquire the Orchard Meadows Apartment Homes community, with a sale taking place in January 2024. This acquisition was supported by \$2 million in County funds through the Department of Housing and Community Development. The acquisition of Orchard Meadows brings 240 rental units into the Housing Commission's portfolio, of which 48 units are set aside to be maintained as affordable.
