#### **Revenue Overview**

Howard County Budget Director Dr. Holly Sun presented the Council with a PowerPoint presentation regarding the revenues for the proposed FY 26 budget. There was a general discussion about the County's revenue, interest income and General Fund balance. Dr. Sun responded to questions regarding the County Executive's proposed FY26 cost savings measures, cost shifts from the State to the County, and revenues for the Howard County Public School System.

# **Howard Community College**

Dr. Daria Willis, Dr. Ty Stone, and Dr. Shantay provided a brief statement on Howard County Community College's proposed budget requests. They responded to Council questions about the status of current capital projects, the current status of union negotiations, employee turnover, and the Community College's outsourcing of their human resources operations to a private entity.
