**AMENDED MOTION FOR POSTPONEMENT**

Respondents Aidan Morrell, Sara Morrell, Golash Adadey, Nana Adadey, Hari Srinivasan, Mustafa Khaliqi, Anwer Hasan, Aisha Hasan, Rasa Ramadas, Padma Swamy, Shamioka Preston, Raja Syed, Nusrat Siddique, Arundati Khuvel, Monica Tolentino, AmiCietta Clarke, Zain Qazi, and Senthil Achari (collectively, “Respondents”), by their attorney, Grant Amadeus Giel, file this formal Amended Motion for Postponement of the August 21 and 28, 2025 hearing dates and, for reasons, say:

1. Counsel represented Respondents in the proceedings before the Hearing Examiner.
2. On June 30, 2025, the Hearing Examiner issued a Decision and Order in Appellees’ favor.
3. On July 15, 2025 Appellant W.R. Grace & Co.-Conn (“W.R. Grace”) filed a Petition of Appeal of Hearing Examiner Decision to the Howard County Board of Appeals. Respondents’ counsel was not given notice of the appeal.
5. On July 16, 2025, Respondents’ counsel learned from the Board administrator Kel Berg that the above-captioned case was scheduled for a hearing before the Board of

Appeals on August 21, 2025 at 9:00 a.m., with pre-scheduled continuances, if needed, on August 28, 2025 and September 4, 2025.

6. Respondents file this Motion for Postponement for the first and second hearing dates. Respondents' counsel is unavailable on August 28, 2025 because he is out of state on that date, and key witnesses for Respondents' case have similar scheduling conflicts on August 21, 2025.

7. Respondents respectfully request that the continuance date for the above-captioned case, September 4, 2025, be maintained, as there are no apparent conflicts on that date for either Respondents' counsel or witnesses.


8. Respondents also request that any further proposed continuance dates be discussed with both Respondent's and W.R. Grace's counsel, to ensure the availability of all necessary persons.

9. In accordance with Code §2.207, Respondents' counsel certifies that a copy of this Motion was provided to all persons known to have an interest in the case including, but not limited to: W.R. Grace, W.R. Grace's counsel, the administrative agency, the Hearing Examiner, the Board of Appeals, all adjoining property owners, and any other person entitled to written notification under Rule 2.203(e) and (f), as the case may be. Counsel further certifies that counsel stated in such correspondences that, "Any person interested in responding to the motion shall file a written response with the Board within 15 days of the date that the motion was filed."

10. After submission of the original Motion on July 22, 2025, Respondents' counsel became aware that they had used the wrong case header from another case before the Board

of Appeals. They have corrected the header in this Amended Motion and submitted new copies of the Amended Motion to all persons identified in the service certificate.


