1. Acceptance of Meeting Minutes from August 28, 2025

Chair Salem moved to approve the minutes of the August 28, 2025, meeting. The motion was seconded by Vice-Chair Downs.

The motion to approve the August 28 meeting minutes passed unanimously.

2. Other Business/Follow Up

Nicholas Rinehart, Senior Administrative Analyst, provided an update on the timeline for the public hearing for the draft Rules of Procedure for the Inspector General Advisory Board.

Mr. Rinehart informed the Board of advertising and noticing requirements for the public hearing, according to the County Code, and gave the Board four options for the public hearing: October 27th, October 30th, November 4th, and November 10th; the meeting start time would be 7pm for all the proposed dates.

The Board unanimously agreed to hold the public hearing on October 30th at 7 pm.

Isaiah Anderson, Executive Assistant I, informed the Board that staff will need to start planning out Inspector General Advisory Board meetings for 2026, and requested that Board members start to

Board members agreed to make a firm decision at a future meeting after the Inspector General is hired.
