DECISION AND ORDER

The Board of License Commissioners for Howard County, Maryland (the "Liquor Board"), pursuant to Rule 1.02(A) of the Liquor Board Rules and Regulations, has delegated the authority to hear and decide cases to the Alcoholic Beverage Hearing Board for Howard County, Maryland (the "Hearing Board").

On October 28, 2025, the Hearing Board heard the application of Anthony DiGangi and Michael Wayne Salandra (the "Applicants"), on behalf of Barrington, LLC t/a Barrington Tap & Table ("Barrington Tap & Table"), for a transfer of a Class B Beer, Wine, and Liquor, 7-Day on/off sale License for a 2,775 sq. ft. restaurant with a 788 sq. ft. deck located at 2050 Marriottsville Road, Marriottsville, MD 21104.

The hearing was properly advertised, and the property posted pursuant to the Alcoholic Beverages Article of the Annotated Code of Maryland. The Applicants were represented by Sang Oh, Esquire and there were no protestants who appeared in opposition to the application.

All the documents on file were incorporated into the record by reference.

SUMMARY OF TESTIMONY

Anthony DiGangi, 20% interest holder and proposed resident agent, was sworn in and

testified before the Hearing Board.

Mr. DiGangi testified that he will be managing the operations of the restaurant, that he has been a resident of the state of Maryland since 2016, and that he has never been convicted of any alcohol-related violations or felonies. Mr. DiGangi stated that he holds a liquor license at Walkers Tap & Table in Howard County and that Barrington Tap & Table will have the same restaurant team. Mr. DiGangi stated that he has been in the restaurant industry since the age of 11 and that he will be at Barrington Tap & Table every day. Mr. DiGangi stated that any alcohol sold for off-premise consumption will be sold in conjunction with food through a bartender and that customers will be carded appropriately. Mr. DiGangi stated that the hours of operation will be from 11 a.m. until 9 p.m. on Sunday, 11 a.m. until 10 p.m. Friday and Saturday, and that they will be temporarily closed on Mondays until 2026.

Mr. DiGangi stated that the existing deck is fenced off at the back of the building with an emergency exit staircase and that staff will monitor customers to ensure that no open containers leave the premises. Mr. DiGangi stated that he is Alcohol Awareness Certified and that any employees serving alcohol will be Alcohol Awareness Certified. Mr. DiGangi stated that he understands his role as the resident agent and that he is familiar with the Howard County Liquor Board Rules and Regulations. Mr. DiGangi stated that parking should not be an issue, that he is community driven and that he will seek opportunities to partner with the public. Mr. DiGangi stated that Walker's Tap & Table has a growler permit and that it has been open since 2019. Mr. DiGangi stated that alcohol sales at the restaurant will be about 30 percent of the gross sales, that there is a full bar on-site, and that the restaurant is currently closed until the required permits are obtained. Mr. DiGangi stated that about 90% of the hourly employees have been retained and that they promote from within. Mr. DiGangi stated that they plan to have 20 rotating draft beer lines

with 19 local beers. Mr. DiGangi stated that the restaurant has 112 interior dining seats, 13 bar seats, 2 communal tables and 50 seats outside. Mr. DiGangi stated that a shift will have 5 to 7 servers working, and that in the future, they will apply for a growler permit.

Pursuant to Rule 6.13 of the Liquor Board Rules and Regulations, the Applicants waived their right to request the Liquor Board to hear the case.

Based on the evidence presented at the hearing, the Alcoholic Beverage Hearing Board makes the following Findings of Fact and Conclusions of Law:

FINDINGS OF FACT

- 1. The Hearing Board finds that Anthony DiGangi and Michael Wayne Salandra (the "Applicants"), on behalf of Barrington, LLC t/a Barrington Tap & Table ("Barrington Tap & Table"), have applied for a transfer of a Class B Beer, Wine, and Liquor, 7-Day on/off sale License for a 2,775 sq. ft. restaurant with a 788 sq. ft. deck located at 2050 Marriottsville Road, Marriottsville, MD 21104.
- 2. The Hearing Board finds that the Applicants are fit and proper persons to hold an alcoholic beverage license.
- 3. The Hearing Board finds that Anthony DiGangi, the resident agent applicant, meets the requirements of Rules 1.10(S), 1.10(T), and 2.06 of the Liquor Board Rules and Regulations concerning resident agent qualifications.
- 4. The Hearing Board finds that the granting of the application is necessary for the accommodation of the public.
- 5. The Hearing Board finds that the granting of the application will not unduly disturb the peace and safety of the residents of the neighborhood.

CONCLUSIONS OF LAW

- 1. The Hearing Board concludes that Anthony DiGangi and Michael Wayne Salandra (the "Applicants"), on behalf of Barrington, LLC t/a Barrington Tap & Table ("Barrington Tap & Table"), have applied for a transfer of a Class B Beer, Wine, and Liquor, 7-Day on/off sale License for a 2,775 sq. ft. restaurant with a 788 sq. ft. deck located at 2050 Marriottsville Road, Marriottsville, MD 21104.
- 2. The Hearing Board concludes that the Applicants are fit and proper persons to hold an alcoholic beverage license.
- 3. The Hearing Board concludes that Anthony DiGangi, the resident agent applicant, meets the requirements of Rules 1.10(S), 1.10(T), and 2.06 of the Liquor Board Rules and Regulations concerning resident agent qualifications.
- 4. The Hearing Board concludes that the granting of the application is necessary for the accommodation of the public.
- 5. The Hearing Board concludes that the granting of the application will not unduly disturb the peace and safety of the residents of the neighborhood.

ORDER

For the foregoing reasons, it is this \(\frac{1}{1} \) May of \(\frac{November}{1} \), 2025, by the Alcoholic Beverage Hearing Board of Howard County \(\text{ORDERED} \) that the application of Anthony DiGangi and Michael Wayne Salandra (the "Applicants"), on behalf of Barrington, LLC t/a Barrington Tap & Table ("Barrington Tap & Table"), for a transfer of a Class B Beer, Wine, and Liquor, 7-Day on/off sale License for a 2,775 sq. ft. restaurant with a 788 sq. ft. deck located at 2050 Marriottsville Road, Marriottsville, MD 21104, be and the same is hereby \(\text{GRANTED}, \) subject to the following conditions:

- (a) That the Applicants comply with all State and County laws and regulations;
- (b) That the Applicants satisfy any requirements necessary to obtain the license by April 28, 2026 unless that deadline is extended by the Hearing Board upon good cause shown; and
- (c) Failure to comply with these conditions shall render this Proposed Decision and Order null and void.
