
EQUAL BUSINESS OPPORTUNITY COMMISSION (EBOC)

The Commission's ongoing role is to assist the efforts of the county in procuring goods and services from minority business enterprises, women business enterprises and disabled business enterprises pursuant to the County's Equal Business Opportunity Program.

During this fiscal year, 206 companies received Howard County EBO certification, 79 of which were based in Howard County. 41 of the 206 were new certifications and 165 were recertifications. A breakdown by EBO type is listed below:

- 86 African Americans
- 19 Hispanic Americans
- 42 Asian Americans
- 0 Native Americans
- 49 Caucasian Females
- 10 Disabled



In fiscal year 2025, the County did \$71,596,653 worth of business with Minority Business Enterprises (MBEs), Women Business Enterprises (WBEs) and Disabled Business Enterprises (DBEs). This includes direct purchases and subcontracting arrangements and represents 20.55% of all purchasing.



The chart below illustrates the total EBO participation from FY 2021 through FY 2025





EBO OUTREACH

The Office of Procurement and Contract Administration undertook several outreach and marketing initiatives in order to promote awareness of the EBO Program in FY25:

Virtual Classes

In order to ensure continuous engagement and provide opportunities for local Howard County based businesses, and minority, women-owned and disabled-owned business enterprises, the Office of Procurement and Contract Administration conducted quarterly virtual classes to provide educational resources and guide vendors through the procurement process, vendor registration and certifications in the Howard County Local Business Initiative and Equal Business Opportunity (EBO) Programs. Advertising and Marketing

The Office of Procurement and Contract Administration advertised its Local Business Initiative Program in the Howard County Chamber Business Resource Guide and Directory 2025.

ECONOMIC DEVELOPMENT AUTHORITY

The mission of the Howard County Economic Development Authority (HCEDA) is to promote economic growth and stability by providing resources to support small businesses. Eighty percent of the approximately 11,000 businesses in Howard County have fewer than 20 employees. HCEDA is pleased to offer resources specifically targeted at supporting the growth of these small, minority- owned, and women-owned businesses which continue to be an economic driver for the County.

In FY 2023, HCEDA expanded its capacity to serve the small and minority business community by adding a Small and Minority Business Development Officer to its business development team. HCEDA's strategic plan goals were updated to include increasing minority business outreach and community engagement.

In FY 2025, HCEDA conducted 551 business assistance cases for minority-owned businesses, representing forty-two percent (42%) of all service cases. HCEDA continues to grow its minority-owned business directory initiative and develop opportunities to connect with community resource partners. HCEDA hosts quarterly minority business roundtable discussions to promote awareness of resources available to the community.

HCEDA manages various loan and business incentive programs to support Howard County businesses. The Catalyst Fund is funded by Maryland's Video Lottery Terminal (VLT) Small, Minority and Woman-owned Business Account initiative. The fund is used to finance growing businesses in Howard County and Statewide for projects which will create permanent jobs and leverage private sector investment. In FY 2025, HCEDA approved 9 loans totaling \$1.99 million. Eighty-nine percent (89%) of the loans were approved to minority, women, and veteran-owned business. HCEDA also recently introduced a program called the Leveraging Investment for Future Transformation Fund, or "LIFT" Fund, enables HCEDA to provide microloans ranging from \$10,000 to \$30,000 to small businesses for a 3–5-year term. The LIFT program primarily serves small businesses including minority-owned, women-owned, veteran-owned, and other socially disadvantaged groups. In FY 2025 HCEDA approved 10 LIFT Fund loans totaling \$290,000. Ninety percent (90%) of loans went to minority and women-owned businesses. HCEDA

continues to market the Collateral Assistance Program to promote access to capital and growing businesses who may experience a shortfall in collateral. HCEDA also continues to host regular, free information sessions for interested candidates to learn more about Catalyst Loan Fund programs and resources available to small businesses. In 2025, HCEDA started the FLEX Line of Credit program for businesses with cash flow shortfalls looking for short-term capital to bridge the gap. Businesses in Howard County can now apply for lines of credit between \$30,000 and \$100,000. This program is for businesses that might not qualify for regular bank lending but still have high potential for growth.

HCEDA supports innovation and entrepreneurship through its programs, Mentorship and Partner Resources offered at the Maryland Innovation Center (MIC). MIC currently hosts 46 resident companies, 55 affiliate companies, and supports a membership of 525 in The Circle, a free networking membership (formerly known as the Howard Tech Council). Eighty four percent (84%) of MIC's resident and affiliate companies identify as minority, women, veteran, or disabled-owned businesses. The MIC's BRITE program (Business Revitalization Initiative Through Entrepreneurship) is focused on providing early-stage startups and existing businesses in Howard County with direct pathways to entrepreneurial success. In FY 2025, the BRITE program educated 1102 attendees and facilitated 572 mentoring sessions that empower the growth and success of new, emerging businesses across industries and sectors: B2B, B2C, B2G and combinations therein, as well as within the services, technology, and consulting.

Mentorship continues to be a big focus for the MIC, ensuring experts are on call to help answer Member questions, in order to help them further grow and scale their business. The MIC is proud to uphold its commitment to offering of free small business counseling through its partnerships with the Small Business Development Center (SBDC), Service Corps of Retired Executives (SCORE), Veterans Business Outreach Center (VBOC) and the Procurement Technical Assistance Center (PTAC). A new partnership forged this year was with the Hutch Foundation. Through this relationship, the MIC/EDA is sponsoring MIC Members interested in going through its Fearless Accelerator aimed at developing government contractor businesses.
