The Chairperson convened the closed session at **6:13 p.m.** in the Council's Large Conference Room.

The County Council held a Special Meeting to determine the need for a closed session on December 1, 2025, at 6:05 p.m. The open portion of the meeting was held in the Banneker Room.

During the open portion of the meeting, there was discussion by Council members regarding their intent to conduct any voting action in an open session. Therefore, if determined a closed session was necessary, the Council would reconvene back in open session in the Banneker Room.

Chair Liz Walsh moved that the meeting be closed in accordance with Section 3-305(b)(1) and (7) of the General Provisions Article of the Annotated Code of Maryland to discuss the appointment, employment, assignment, promotion, discipline, demotion, compensation, removal, resignation, or performance evaluation of appointees, employees, or officials over whom the County Council has jurisdiction; or any other personnel matter that affects one or more specific individuals; and to consult with counsel to obtain legal advice on a legal matter. The topics are performance, removal, and resignation of one or more Board Members and legal advice from counsel regarding that personnel matter. Council Member Opel Jones seconded the motion.

The roll call vote called by the Administrator on the motion was: Yea: Council Members Liz Walsh, Opel Jones, Deb Jung, and David Yungmann.

The motion to close the meeting in accordance with Section 3-305(b)(1) and (7) of the General Provisions Article of the Annotated Code of Maryland passed.
