The Chairperson convened a special meeting at **12:02 p.m.** virtually via WebEx.

**Council Members Present for the Special Meeting to Determine Closed Session:** Opel Jones, Deb Jung, Christiana Rigby, Liz Walsh, and David Yungmann.

**Staff present:** Michelle Harrod, Administrator to the County Council; Gary Kuc, County Solicitor; Amanda Mihill, Assistant County Solicitor; Isaiah Anderson, Executive Assistant I; and Trish Hammond, Administrative Assistant.

The County Council held a Special Meeting to discuss generally the status of Board of Appeals resignations. Dr. Jones provided a brief summary of his understanding regarding resignations, specifically since there was not a vote by the Council as a Body to accept BOA resignations, none of the resignations were properly accepted. There was general discussion regarding the status of resignations and requests to rescind. Ms. Jung suggested that the topic should be discussed in closed session. Mr. Yungmann indicated there was a need to have follow up discussions with various Board members. Ms. Walsh indicated her understanding was that resignations could not be rescinded.

The Council then determined the need for a closed session on December 22, 2025, at 12:22 p.m.

During open session, Chair Opel Jones moved that the meeting be closed in accordance with Section 3-305(b)(1) and (7) of the General Provisions Article of the Annotated Code of Maryland to discuss the appointment, employment, assignment, promotion, discipline, demotion, compensation, removal, resignation, or performance evaluation of appointees, employees, or officials over whom the County Council has jurisdiction; or any other personnel matter that affects one or more specific individuals; and to consult with counsel to obtain legal advice on a legal matter. The topics are performance, removal, and resignation of one or more Board Members and legal advice from counsel regarding that personnel matter. Council Member Christiana Rigby seconded the motion.

The roll call vote called by the Administrator on the motion was: Yea: Council Members Opel Jones, Deb Jung, Christiana Rigby, Liz Walsh, and David Yungmann.

The motion to close the meeting in accordance with Section 3-305(b)(1) and (7) of the General Provisions Article of the Annotated Code of Maryland passed.

The virtual WebEx for the special meeting was recessed at 12:22 p.m., and another virtual WebEx was started for the closed session.

The Council discussed performance, removal, and resignation of one or more Board Members and obtained legal advice regarding that topic. The following actions were taken by Council during the Closed Session:
