#### Council Bill No. 51-2020

#### Fiscal Impact:

The future fiscal impact of this legislation cannot be readily determined. However, based on historic revenues and the direct expenditures, illustrated in the chart below, the future net County General Fund (GF) revenues could be reduced by approximately \$2 million.

**NOTE:** Future net revenues will likely be impacted by the following:

- Revenues for Fiscal Year 2021 are reduced due to the COVID-19 pandemic. To maintain social distancing, the Detention Center has reduced the 110 U.S. Immigration and Customs Enforcement (ICE) bed allocation to 24 beds. Because there will likely be offsetting reductions in expenditures, the net effect is difficult to estimate. For detailed information of the average daily number of ICE detainees, refer to **Exhibit B**.
- According to the Director of the Department of Corrections (Corrections), there will be reductions of direct and possibly indirect expenses as a result of this legislation. However, we cannot determine the extent of indirect costs that may be affected.

#### Purpose:

This bill would prohibit Corrections from detaining or housing any individual being detained by federal authorities for federal immigration violations except under very limited circumstances.

#### Other Comments:

According to the Director of Corrections, the federal per diem of \$110 to house each ICE detainee was negotiated based upon Fiscal Year 2017 expenditures. At that time, Detention Center personnel calculated the estimated bed rate using the ICE Fiscal Estimate Worksheet, which was calculated at \$113 per day.

This calculation included the direct and overhead costs of the detention center (\$19.1 million), divided by 365 and the number of beds at total capacity (463).

Recently, the Director was asked to provide a current per diem rate. He has indicated that a rate of \$118 per diem was estimated by using the Fiscal Year 2017 data (resulting in \$113) with a two percent annual rate of inflation. The Director did not recalculate the per diem based upon current actual expenditures.
